Terms & Conditions

1. The person who completes this form will be the activity organizer, which makes them solely accountable for managing the fundraising activity, gift certificates, and all monies in an appropriate and responsible way.
2. It's up to the activity organizer to ensure the safety of the activity, including organizing appropriate public liability insurance if needed.
3. You need to fulfill any legal obligations for fundraising and comply with any regulations. You will also need to organize any permits, licenses, insurance or authorities to fundraise where necessary. This information will be available from your provincial government, local council, or board of directors.
- 4.a. You will need to hold on to all monies you collect during the duration of your fundraising activity (30 days). Monies need to be turned in to District 8 Entertainment Group Ltd. immediately following the completion of the fundraising activity.
- 4.b. Any monies or gift certificates that are missing from the sale, are the sole responsibility of the organizer and must be paid in full to District 8 Entertainment Group Ltd.
- 4.c. All gift certificate sales are final and there are no refunds.
- 5.a. Once District 8 Entertainment Group Ltd. has collected all monies, the team/organization will be given their fundraising portion.
- 5.b. If there are any team builder exercises provided by District 8 Entertainment Group Ltd., those will be booked at our discretion.

6. District 8 Entertainment Group Ltd. reserves the right to audit paperwork associated with the event/fundraising activity. Organizers are responsible for keeping all paperwork relevant to the event/fundraising activity until December 31 of the year your event/fundraising activity was held.

7. Any promotional material and collateral that uses the District 8 Escape logo must be reviewed before going to print or being distributed in any format. District 8 Entertainment Group Ltd. may use your logos as promotional items on the website, social media, email marketing, etc.

8. You are not able to approach the general public with door to door or telephone collections as part of your fundraising activity.

9. People less than 16 years of age collecting donations or money must have an adult with them.

10. You agree to release District 8 Entertainment Group Ltd. to the fullest extent permissible under law for all claims and demands of any kind associated with the activity and indemnify District 8 Entertainment Group Ltd. for all liability or costs that may arise in respect to any damage, loss or injury occurring to any person in any way associated with the activity caused by your breach of these responsibilities or negligence.

11. District 8 Entertainment Group Ltd. reserves the right to withdraw your authority to fundraise at any time.

12. District 8 Escape Ltd.'s authorization of your event may be issued at the absolute discretion of District 8 Escape Ltd. based on the information you have provided. If authorization is given, it is given in reliance on your having given us honest and truthful information regarding your event and any risks or hazards to which participants may be exposed. District 8 Escape Ltd. will inform you before authorizing your event whether your proposed event will be covered by terms and conditions.
